Dear Licensee:

An Exposition Permit is hereby granted to the above-referenced licensee for the premises/location listed herein. The hours of operation are limited to the hours permitted by law for your license type.

The Board's approval of an Exposition Permit is subject to the following conditions and restrictions:

- You must have an active license at the time of the event.
- Expositions must be held on an otherwise unlicensed premises.
- The expositions are for affairs held indoors or outdoors with the primary intent of educating those in attendance about Pennsylvania products.
- This permit authorizes sales of your product in volumes permitted under the authority of your license.
- It also authorizes you to conduct tastings in individual portions as permitted by law. No more than one standard-sized alcoholic beverage of each product shall be provided to each tasting participant. A standard size alcoholic beverage is four fluid ounces of a malt or brewed beverage, one fluid ounce of wine (including fortified wine) or one and one-half fluid ounces of spirits.
- The areas approved by this permit must be defined by physical separation from any other areas or businesses, so as to clearly delineate the areas under the sole control for the purpose of the event and the subject permittee.
- You are required to notify the local police for the municipality where the permit is being held as well as the local or state police for the municipality where the main winery/brewery/distillery is located.
- The Board reserves the right to request additional information at any time.

Please note that you are limited to 100 events under the Exposition Permit during a calendar year (not to exceed 30 consecutive days).

To apply for the first permitted exposition in a new calendar year, you must choose to apply for an Exposition Permit. After the first permit has been approved, in order to apply for additional permitted expositions throughout the year, you must apply through the "Manage Events" section on your homepage. If you cancel an approved permit prior to the event being held, the \$30.00 fee will be placed in your account and can be used for future permits. **Please note that at no time will refunds be issued for any pending credits on your account.**

Any violation of these terms, or any other violation of the Liquor Code or the Board's Regulations occurring under the authority of your Exposition Permit, may be the basis for the issuance of a citation under section 471 of the Liquor Code, the

nonrenewal of your license under section 470, or the refusal by the Board to issue subsequent permits. The Bureau of Liquor Control Enforcement of the Pennsylvania State Police is responsible for enforcement of the Liquor Code and the PLCB regulations.
